Insurance Verification Process

- We verify your benefits as a courtesy service
- Benefit quotes are not guarantees of payment
- Claims process according to your specific plan terms
- Patients are responsible for understanding their coverage

Patient Financial Responsibilities

- **Copays, deductibles, and coinsurance** are due at check-in
- **100% responsibility** for all charges incurred
- **Referrals** from other physicians do not guarantee coverage
- **Balance adjustments** will be billed or refunded as applicable

Electronic Processing

Card on File Requirement

- **Mandatory:** All patients must maintain a valid credit or debit card on file
- **Updates:** Notify us immediately of card changes
- **Non-compliance:** May result in appointment cancellation

Financial Policies

Payment Due at Service

- Payment is expected at the time of service
- Prior financial arrangements must be approved in advance
- Late payments may affect scheduling privileges

Insurance Claims

- We submit claims to insurance as a courtesy
- Patients remain responsible for all charges
- Insurance denials do not eliminate patient responsibility

Billing Disputes

- Contact our billing department promptly with concerns
- Insurance disputes should be directed to your carrier



- We will assist with documentation as needed

Verify Your Coverage

We strongly recommend contacting your insurance carrier to:

- Understand your mental health benefits
- Confirm coverage for specific services
- Clarify deductibles and out-of-pocket maximums
- Verify in-network status

Multiple Insurance Plans

Having multiple insurance policies does not guarantee zero patient responsibility. Coordination of benefits applies according to insurance regulations.

Financial Hardship

Patients experiencing financial difficulties should contact our billing department to discuss:

- Payment plan options
- Financial assistance programs
- Alternative payment arrangements
